**AUTHORIZING ACCEPTANCE OF THE OBLIGATIONS UNDER GRANT AGREEMENT #2021-04960-0471-00  
LOCAL RECREATIONAL IMPROVEMENT 2021 - NICODEMUS SPLASH PAD GRANT**

**Whereas**, the Borough of Eatontown applied for and was awarded 2021 Local Recreation Improvement Grant funds in the amount of \$60,000 to construct and install the Eatontown Nicodemus Park Splash Pad, and;

**Whereas**, the purpose of the grant funds are awarded to construct and install a splash pad, and;

**Whereas**, the New Jersey Department of Community Affairs, Division of Local Government Services, 101 South Broad St. PO Box 803, Trenton NJ 08625-0803 requires the Mayor and Council of the Borough of Eatontown to accept the obligations under the grant agreement by resolution, and;

**Whereas**, the Borough of Eatontown resolution must state the following:

- A. Legally incorporated name of the organization: Borough of Eatontown, 47 Broad St., Eatontown, NJ
- B. Dollar amount of grant award requested: \$60,000
- C. Brief Description of Project: This award will provide funding for construction and installation of a splash pad at Nicodemus Park, Eatontown NJ.
- D. List name title, and signature of person who may sign agreement as the authorized agency official:  
Mayor, Anthony Talerico, Jr.
- E. This resolution is imprinted with a raised Government seal, certified, signed and dated by the Municipal Clerk. This certification states the name of the Municipal Clerk.

**Now, Therefore Be It Resolved:**

- 1. The Borough of Eatontown does hereby authorize and accept the terms and conditions of the grant agreement from the New Jersey Department of Community Affairs.
- 2. The Borough of Eatontown authorizes the expenditure of funds pursuant to the terms of the agreement between the Borough of Eatontown and the New Jersey Department of Community Affairs.

**Be It Further Resolved**, that the Mayor and Clerk are authorized to sign the grant agreement and that they or their successors in said titles are authorized to sign any other documents necessary in connection therewith.
