ORDINANCE AMENDING “LOSAP POINT SYSTEM BASED ON 100 POINTS”

WHEREAS, Eatontown Engine Truck & Hose, Co. 1 has proposed changes to the LOSAP point system, and same must be modified accordingly.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Eatontown that it hereby amends Article II, Chapter 35-9, Section A, Schedule A amending the LOSAP Point System for First Responders as follows:

- I. Officers (Sections A-L, N-P remain unchanged)

 - M. Delegate / Life (Relief/Exempt) _____ 10
 - Delegate must attend the Caucus and

 - Wildwood to be eligible for the 10 points.
- II. Fire Calls

 - ~~Life – 35%~~ _____ 40
 - ~~1 point for each percentage point over 20% up~~
 - ~~to a maximum of 40 points [Added 12-3-2008~~
 - ~~by Ord. No. 26-2008]~~
 - Active – 25% _____ 40
 - Exempt – 20% _____ 40
 - Life – 15% _____ 40
 - 1 point for each percentage point over 25% up
 - to a maximum of 40 points.

IT IS FURTHER ORDAINED THAT all other provisions of such Ordinance not modified by this Ordinance shall remain in full force and effect.

IT IS FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.
