### ORDINANCE 11-2024

#### BOROUGH OF EATONTOWN

#### COUNTY OF MONMOUTH, STATE OF NEW JERSEY

#### AN ORDINANCE OF THE BOROUGH OF EATONTOWN AMENDING CHAPTER 150 “FEES”, ARTICLE I “COMMUNITY CENTER”, CHAPTER 150-1 “FEE RANGES ESTABLISHED”,”

**WHEREAS**, the Recreation Director has recommended the elimination of certain recreation programs and fee increases to various programs in order to cover the increased costs of such programs; and

**WHEREAS**, the Borough Council believes it is in the best interest of its residents to ensure that its recreational programs are financially sound.

**NOW THEREFORE BE IT ORDAINED**, by the Borough Council of the Borough of Eatontown, County of Monmouth and State of New Jersey that it hereby amends Chapter 150 “Fees”, Article I “Community Center, Section 150-1, “Fees Range Established” as follows:

#### **Section 150-1**

Fee ranges, as hereinafter set forth, are established:

#### A.

Preschool (registration): \$50.

#### C. B.

#### D. C.

Summer camp (per week session): \$165 \$185.

#### E. D.

Three day preschool for residents (per month): \$220 Enrichment Program Fee: \$12.50 per child/per hour.

#### F.

Five day preschool for residents (per month) \$330.

#### G.

Three-day preschool program for nonresidents (per month): \$240.

#### H.

Five-day preschool program for nonresidents (per month): \$360.

#### I. E.

[No change].

#### J. F.

Aftercare: \$6 per hour. Before/Aftercare: \$7 per child/per hour.

**BE IT FURTHER ORDAINED**, that

- A. All other Ordinances or provisions of the Code of the Borough of Eatontown or parts thereof, which are inconsistent with any provisions in this Ordinance, are hereby repealed to the extent of such conflict or inconsistency.
- B. If any provision or portion of this Chapter is held to be unconstitutional, preempted by Federal or State Law or otherwise invalid by any court of competent jurisdiction, the remaining provisions of this chapter shall not be invalidated.
- C. This Ordinance shall take effect upon its passage and publication as required by law except for Sections 150-1 (C) and (F) which shall become effective on January 1, 2025.
