RESOLUTION AUTHORIZING BOROUGH ENGINEER TO PERFORM INITIAL SITE INVESTIGATION ENGINEERING  
SERVICES FOR NEW MUNICPAL BUILDING

**WHEREAS**, the Borough Engineer submitted a proposal dated March 7, 2025 for Initial Site Investigation Services, including Ground Penetrating Radar Survey, Initial Environmental Investigation Services, Geotechnical Investigation, Stormwater Management Testing Services, Coordination with the Project Architect and Project Management, in connection with the preparation for the construction of the proposed new municipal building in the collective amount of \$142,945.00 for such services (the "Proposal"); and

**WHEREAS**, the Borough Council of the Borough of Eatontown believes it is in the best interests of the Borough to authorize the proposed engineering services set forth in the Proposal in order to move forward with the required engineering services for the construction of the proposed new municipal building.




