AN ORDINANCE OF THE BOROUGH OF EATONTOWN AMENDING CHAPTER 150 "FEES", ARTICLE I "COMMUNITY CENTER", CHAPTER 150-1" FEES RANGE ESTABLISHED", ARTICLE II "MISCELLANEOUS FEES", CHAPTER 150-5 "OUTDOOR FIELD FEES" AND CHATPER 150-10 "RECREATION PROGRAM"

WHEREAS, the Recreation Director has recommended fee increases to various programs in order to cover the increased costs such programs; and

WHEREAS, the Borough Council believes it is in the best interest of its residents to ensure that its recreational programs are financially sound.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Eatontown, County of Monmouth and State of New Jersey that it hereby amends Chapter 150 "Fees", Article I "Community Center, Section 150-1, "Fees Range Established", Article II, Sections 150-5 "Outdoor Field Fees" and 150-10 "Recreation Program" as follows:  
(additions are underlined deletions are ~~stricken~~):

**Section 150-1**

Fee ranges, as hereinafter set forth, are established:

A. Latchkey/~~Day~~ Child Care (registration): \$50.

**Section 150-5 Outdoor Field Fees**

A. Usage fees.

(1) Those applicants meeting the definition of "resident" shall pay a fee of \$20 ~~\$50~~ per use, per field. This fee covers a two-hour time-frame, and the fee for each additional hour is ~~\$10~~\$25 and shall become effective January 1, 2023.

(2) Those applicants not qualifying as "resident" shall pay a fee of \$40 ~~\$100~~ per use, per field. This fee covers a two-hour time-frame, and the fee for each additional hour is ~~\$20-\$50~~ and shall become effective January 1, 2023.

**Section 150-10 Recreation Programs**

A. Program	Individual	Family

Youth—	\$5	\$10
Adult—	\$10	
<u>The fee shall be \$10 per participant</u>		
Instructional Programs	\$60	\$80 (maximum)
<u>The fee shall be \$75 per participant.</u>		
Youth Leagues		
Recreation	\$45	\$65
Traveling Team	\$75	\$105 (maximum)
<u>The fee shall be \$95</u>		
Contractual programs	\$50	\$75
<u>These rates shall become effective September 1, 2022.</u>		

B. Summer Day Camp: \$90 for first child, and \$140 for each additional. \$295 per camper. This rate shall become effective for the Summer 2023 program.

**BE IT FURTHER ORDAINED**, that


- A. All other Ordinances or provisions of the Code of the Borough of Eatontown or parts thereof, which are inconsistent with any provisions in this Ordinance, are hereby repealed to the extent of such conflict or inconsistency.
- B. If any provision or portion of this Chapter is held to be unconstitutional, preempted by Federal or State Law or otherwise invalid by any court of competent jurisdiction, the remaining provisions of this chapter shall not be invalidated.

This Ordinance shall take effect upon its passage and publication as required by law.
