

ORDINANCE 17-2021

COUNTY OF MONMOUTH, STATE OF NEW JERSEY

AN ORDINANCE OF THE BOROUGH OF EATONTOWN AMENDING CHAPTER 55 OF THE BOROUGH CODE ENTITLED "POLICE DEPARTMENT" SECTION 6 ENTITLED "ESTABLISHMENT" TO ADD TWO POLICE OFFICERS AND ONE SERGEANT TO THE POLICE DEPARTMENT AND TO AMEND THE POLICE DEPARTMENT ORGANIZATIONAL CHART

WHEREAS, pursuant to N.J.S.A 40A:14-118, the Borough of Eatontown ("Borough"), is authorized to establish a police department and provide for the appointment of such officers and personnel which the Borough determines is necessary for the effective governance of the Department; and

WHEREAS, the Borough's police department currently consists of one Chief of Police, one Captain, three Lieutenants, six Sergeants and 26 Patrol Officers; and

WHEREAS, the Chief of Police has recommended to the Borough Council that two additional police officers and one additional sergeant are necessary for effective governance of the Department and to ensure the health, safety and welfare of the public; and

WHEREAS, the Borough Council, upon recommendation from the Chief of Police, has determined that the current Department organizational chart requires revisions considering the additional officers; and

WHEREAS, the Borough Council believes that it is in the best interests of the Borough and its residents to provide for additional officers and adopt a new organizational chart for the Department.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Eatontown, County of Monmouth and State of New Jersey that the Code of the Borough of Eatontown, entitled, is hereby amended as follows:

Chapter 55 entitled "Police Department" Section 6 entitled "Establishment" of the Code of the Borough of Eatontown shall be amended as follows (additions are underlined deletions are ~~stricken~~):

§ 55-6 Establishment.

- A. The Police Department of the Borough of Eatontown is hereby established and shall consist of a Chief of Police, who shall serve as head of the Department, and such members and officers as shall be deemed necessary by the governing body. The governing body shall, from time to time, determine the number of persons, including temporary officers and members in an emergency, to be appointed to the positions, together with their compensation.
- B. The Police Department shall consist of one Chief of Police, one Captain, three Lieutenants, ~~six~~ seven Sergeants and ~~26~~ 28 Patrol Officers, which the Borough Council deems necessary to preserve the peace of the Borough.
- C. The Organizational Chart shall be as follows: see attached Exhibit A as adopted by Ordinance 17-2021

BE IT FURTHER ORDAINED, that

- A. The Police Department Organizational Chart attached hereto as Exhibit A is hereby adopted.
- B. All other Ordinances or provisions of the Code of the Borough of Eatontown or parts thereof, which are inconsistent with any provisions in this Ordinance, are hereby repealed to the extent of such conflict or inconsistency.
- C. If any provision or portion of this Chapter is held to be unconstitutional, preempted by Federal or State Law or otherwise invalid by any court of competent jurisdiction, the remaining provisions of this chapter shall not be invalidated.
- D. This Ordinance shall take effect upon its passage and publication as required by law.


