

ORDINANCE 02-2021

BOROUGH OF EATONTOWN
COUNTY OF MONMOUTH, STATE OF NEW JERSEY

AMENDING CHAPTER 150 ENTITLED "FEES", ARTICLE 1 ENTITLED "COMMUNITY CENTER",
SECTION 150-1 TO INCREASE CERTAIN FEES

WHEREAS, pursuant to N.J.S.A. 40:48-1, the Governing Body of the Borough of Eatontown may make and amend ordinances which regulate and control the Borough's finances and property; and

WHEREAS, the Borough Recreation Department has evaluated the costs and fees of providing important public services to the youth and parents of the Borough residents, including summer camp and pre-school program activities, and it has recommended an increase in fees for certain programs; and

WHEREAS, the Mayor and Borough Council believe it is in the best interest of the Borough to accept the recommendation of the Recreational Department to ensure it can continue to provide these important programs and services without burdening the taxpayers; and

NOW, THEREFORE, BE IT ORDAINED by the MAYOR AND COUNCIL OF THE BOROUGH OF EATONTOWN, COUNTY OF MONMOUTH, STATE OF NEW JERSEY that the Borough Code is hereby amended as follows:

SECTION 1 (150-1)

Chapter 150, Article I, Subsection 150-1, entitled "Fee Ranges Established" is hereby amended as follows (additions are underlined; deletions are [bracketed]):

§ 150-1 Fee ranges established.

Fee ranges, as hereinafter set forth, are established:


- A. Latchkey/day care (registration): \$50.
- B. Preschool (registration): \$50.
- C. Summer camp (registration): \$50.
- D. Summer camp (per week session): \$150 [\$165].
- ~~E. Two-day preschool of residents (per month): \$135~~
- ~~F. [E.] Three-day preschool for residents (per month): \$190 [\$220].~~
- ~~G. [F.] Five-day preschool for residents (per month): \$300 [\$330].~~
- ~~H. Two-day preschool for nonresidents (per month): \$160.~~
- ~~I. [G.] Three-day preschool program for nonresidents (per month): \$220 [\$240].~~
- ~~J. [H.] Five-day preschool program for nonresidents (per month): \$330 [\$360].~~
- ~~K. [I.] Youth dances: \$5 [\$10] per dance.~~
- [J. Aftercare: \$6 per hour.]

SECTION 2 EFFECTIVE DATE

This ordinance shall take effect upon passage and publication in accordance with applicable law.


